BOOTH FEES: The balance is due September 12, 2010. Tradeshow Productions may resell your booth space if full payment is not received by then. Exhibitors not paid in full will not be listed in printed material.

CANCELLATION OF BOOTH: Exhibitors canceling before September 18, 2010 will receive all but \$25.00 of their deposits. Deposits are not refundable after September 12, 2010.

BOOTH SHARING: Exhibitors are not permitted to sublet or share booth space.

ELECTRICAL AND RENTAL SERVICES: Exhibitors will be responsible for paying all electrical services and rental of extra equipment (i.e. tables, chairs, etc).

FIRE AND SAFETY REGULATIONS: Exhibitors must adhere to all city and state fire regulations.

FLOOR PLANS: Tradeshow Productions reserves the right to add or delete booth space when necessary.

FOOD: Food and beverage may be given away in trial samples only. No alcoholic beverages are allowed.

LIABILITY INSURANCE: Exhibitors will be required to assume all responsibility for liability insurance.

LITERATURE: Literature may be made available by the exhibitor for pick-up by the consumer. No literature may be handed out or displayed that advertises merchants not participating in the show. Each exhibitor must restrict his activities and materials to the confines of his booth.

BRIDES LIST: Brides lists are the exclusive property of Tradeshow Productions Inc. and shall not be shared with any vendor not participating in the show. Any vendor who shares these lists will not be invited to participate in future shows.
